**PROCEDURE STATEMENT**

The subcontracts prepared by ORED flow down to the subcontractor the required provisions from the sponsor’s prime award and include a provision allowing FIU or the sponsor to perform audits, if necessary. The subcontracts also contain requirements that subcontractors must follow regarding providing audit reports and related documentation to FIU in compliance with Federal law and/or the Florida Statutes Single Audit Act, as applicable.

On an annual basis, ORED Post Award will review all outstanding subcontracts and will obtain the subcontractors’ audits, either directly from the subcontractor or from website resources where the subcontractors have posted their audits.

Post-Award will review and forward to Internal Audit all audit reports. Internal Audit will complete an evaluation form and provide a conclusion of their evaluation determining any action to be taken by FIU. If significant findings relate to an FIU subcontract, the subcontractor must comply with the requirements of the subcontract and the Uniform Guidance, as applicable, including but not limited to, providing a plan of corrective action and returning subcontract funds which were disallowed. This review will also affect the risk analysis for future subcontract agreements to that subcontractor.
