If a proposal includes work by a subcontractor or consultant, the proposal package to Pre-Award must include a Subcontract Commitment Form or a Consultant Commitment Form, as applicable, signed by the consultant or, in the case of a subcontractor, by the subcontractor’s authorized official, detailing, among other things, the scope of work and budget for the subcontractor’s or the consultant’s involvement in the project. The Principal Investigator must also explain how the subcontractor or the consultant was selected for the proposal.

REASON FOR POLICY

To ensure that third parties listed on proposals agree to perform the proposed project, if funded, in accordance with the proposal submitted to the sponsor.

DEFINITIONS	
TERM	DEFINITIONS
Consultant	“Consultant” is a non-FIU employee whose expertise is needed to perform a portion of the technical work on a sponsored project.
ORED	“ORED” is the Florida International University Office of Research and Economic Development.
PI	“PI” is the principal investigator.
Subcontractor	“Subcontractor” is a third-party entity performing a portion of the technical tasks on a sponsored project in accordance with an agreement executed between Florida International University and the third party entity.
