Each PI, Co-PI and key personnel salary position named in the budget on a proposal must designate the percentage of such person's total University professional effort pledged to be spent on the project and the same must be a realistic reflection of his/her planned effort on the project.

REASON FOR POLICY

To ensure that proposed effort on proposals is realistic and to ensure compliance with effort reporting requirements.

ROLES AND RESPONSIBILITIES

PI – The PI must ensure that all faculty and key personnel's effort listed on the proposal is a realistic reflection of the effort each person will be able to provide on the project, if funded.

PI's/Co-PI's Chair - reviews the proposal for, among other things, faculty assignment listed.

PROCEDURE STATEMENT

The total percentage of effort committed by each faculty and key personnel: (1) in budgets of active externally-sponsored projects; (2) as cost sharing and other contributed effort on active externally-sponsored projects and (3) on all other University activities must not exceed 100% of that individual's total University appointment. The percentage of each faculty and key personnel's effort and salary assigned to the proposed sponsored project must be a realistic reflection of his/her planned effort and should take into account teaching and administrative responsibilities, as well as other research responsibilities. If the proposal is funded, the effort expended by FIU personnel on the project must be documented through the University time and effort reporting system.
