POLICY STATEMENT

Based on Florida Statute 1009.26 and Florida Board of Governors Regulations 7.008, tuition and fees may be waived for persons sixty (60) years of age or older, who meet Florida residency requirements set forth in Florida Statute 1009.21 and Rule 6A-10.044, Florida Administrative Code, who wish to enroll in courses for audit.

Enrollment is on a space available basis and with instructor's permission. Independent study, individual instruction, market rate, and/or self-supporting courses are not available under this free course policy.

The AU symbol will be assigned as a grade for audited courses. Courses taken on an audit grading basis do not earn credit, nor is an AU grade used in the GPA calculation.

SCOPE

This policy applies to persons sixty (60) years of age or older who are Florida residents and wish to enroll in classes at the University for audit.

REASON FOR POLICY

To provide the criteria for eligible Florida resident 60 years of age or older to enroll for courses tuition free for audit grade only.

DEFINITIONS

TERM	DEFINITIONS
Florida residency requirements	The requirements defined in state law, Florida Statute 1009.21 and Rule 6A-10.044, Florida Administrative Code, to be classified as a Florida resident for tuition purposes.



Space available basis	A class section that has not reached its designated enrollment capacity.
Audit a course	Taking/completing a course, without taking assessments, receiving a letter grade or credit for the course. Auditing a course is for the purposes of self-enrichment and academic exploration and not for credit.
AU Grade	Grade code for auditing a course. This code is listed on student's transcript and other academic documents similar to a letter grade.

ROLES AND RESPONSIBILITIES

The Office of the Registrar is responsible for ensuring that students who are sixty (60) years of age or older who wish to enroll at the University, meet the Florida residency requirements and have the permission of the instructor to audit the desired course.

PROCEDURE STATEMENT

To be eligible to audit courses under the Florida resident sixty (60) years of age or older fee waiver policy, a student must:

1. Complete the Florida Residents 60 Years of Age or Older Fee Waiver Application;
 - a. Provide proof of age
 - b. Provide proof of Florida residency as required by law in Florida Statute 1009.21 and Rule 6A-10.044, Florida Administrative Code.
2. Complete the Florida Resident Sixty (60) Years of Age or Older Fee Waiver Form;
3. Obtain the permission and signature of the instructor on the Fee Waiver Form;
4. Submit the Fee Waiver Form to OneStop for processing during the add/drop period of the term.

The instructor may deny the auditing of an individual class. No academic credit will be awarded for attendance in classes for which fees are waived under this policy.
